

SEO Recon™ End-User License Agreement

This End-User License Agreement (“EULA”) is a legal agreement between **End-User** (“Licensee”) and Internet Marketing Analysts, LLC (“Licensor”). In the following, “Software” refers to SEO Recon™, any accompanying software, associated print and electronic documentation, as well as software updates, web-based materials, and electronic services that Licensor may provide to Licensee in conjunction with use of this software, to the extent that these items are not accompanied by a separate license agreement. By installing, copying, accessing, or otherwise using this Software, Licensee agrees to be bound by the terms of this EULA. If Licensee does not agree to the terms of this EULA, do not install, copy, access, or otherwise use this Software.

1. Licensee may install Software on **up to the number of machines corresponding to the type of purchased** within Licensee’s company or organization. Licensee may duplicate and distribute Software within Licensee’s company or organization, provided that each copy is a true and complete copy, including all copyright and trademark notices, and includes a copy of this EULA.

Enterprise License: installation on up to 10 machines permitted

Small Business License: installation on up to 2 machines permitted

Individual License: installation on 1 machine permitted

2. Restrictions

a. Licensee may not duplicate, distribute, or make available for use Software outside of Licensee’s company or organization. Licensee may not modify Software in any manner.

b. Licensee may not use this Software or distribute outputs produced by this Software or derivative works thereof unless Licensee have been granted a separate license to do so from Licensor.

3. Warranty of Title, Functionality and Maintenance.

a. Licensor hereby represents and warrants to Licensee that Internet Marketing Analysts, LLC is the owner of the Software or otherwise has the right to grant to Licensee the rights set forth in this Agreement. In the event any breach or threatened breach of the foregoing representation and warranty, Licensee's sole remedy shall be to require Licensor or to either: i) procure, at Licensor's expense, the right to use the Software, ii) replace the Software or any part thereof that is in breach and replace it with Software of comparable functionality that does not cause any breach, or iii) refund to Licensee the full amount of the license fee upon the return of the Software and all copies thereof to Licensor.

b. For a period of one year following delivery of the Software to Licensee (the "Warranty Period"), Licensor warrants that the Software shall perform in all material respects according to the Licensor's specifications concerning the Software when used with the appropriate computer equipment. In the event of any breach or alleged breach of this warranty, Licensee shall promptly notify Licensor and return the Software to Licensor at Licensee's expense. Licensee's sole remedy shall be that Licensor shall correct the Software so that it operates according to the warranty. This warranty shall not apply to the Software if modified by anyone or if used improperly or on an operating environment not approved by Licensor.

c. In the event of any defect in the media upon which the Software is provided arising within one year of the date of delivery of the Software, upon return to Licensor of the Software upon the original media, Licensor shall provide Licensee a new copy of the Software.

d. Standard maintenance. During the Warranty Period, Licensor shall provide to Licensee any new, corrected or enhanced version of the Software as created by Licensor. Such enhancement shall include all modifications to the Software which increase the speed, efficiency or ease of use of the Software, or add additional capabilities or functionality to the Software, but shall not include any substantially new or rewritten version of the Software.

4. Electronic transmission of information:

a. This Software automatically transmits an electronic signature of program inputs via the Internet to a licensing server operated by Licensor. This signature allows Licensor to identify violations on the use of this Software. This signature does not reveal any information related to the internal functionality of program inputs, nor any information outside the scope of program inputs. In addition, Licensor receives and stores the time of use and network identifier of each computer on which this Software is operated. Licensee assents to the transmission, storage, and use of this information by Licensor for purposes of enforcement of this agreement.

b. This Software automatically connects and interacts via the Internet with servers operated by Licensor to implement auto-update features, download data, and perform other operations required to implement product functionality. Licensee assents to this network activity for the purposes of implementing product functionality.

5. Licensee may not reverse engineer, decompile, or disassemble this Software, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

6. Licensee may not use this Software to perform any activity which is or may be, directly or indirectly, unlawful, harmful, threatening, abusive, harassing, tortuous, or defamatory, nor to perform any activity which breaches the rights of any third party.

7. This EULA does not grant Licensee any rights in connection with any trademarks of Licensor.

8. All title and intellectual property rights in and to this Software, including but not limited to all code, algorithms, text, images and other media incorporated into this Software, are owned by Licensor.

9. Licensee acknowledges that this Software is subject to U.S. export jurisdiction. Licensee agree to comply with all applicable national laws and international treaties that apply to this Software, including the U.S. Export Administration Regulations, as well as end-user, end-use, and destination restrictions issued by the U.S. and other governments.

10. Licensee grants Licensor the right to include Licensee's company or organization name in lists of Licensor customers published on its web site and other promotional materials.

11. This EULA is governed by the laws of the State of North Carolina.

12. To the maximum extent permitted by applicable law, Licensor provides this Software AS IS AND WITH ALL FAULTS, and disclaims all warranties and conditions, either express, implied or statutory, including, but not limited to, any implied warranties or conditions of merchantability, of fitness for a particular purpose, of accuracy or completeness, of results, and of lack of negligence, all with regard to this Software. The entire risk as to the quality of or arising out of the use of this Software remains with Licensee.

13. This Software may contain technological defects and omissions, typographic errors, and technical inaccuracies. Licensor may modify this Software at any time.

14. To the maximum extent permitted by applicable law, in no event shall Licensor be liable for any special, incidental, indirect, or consequential damages whatsoever (including, but not limited to, damages for loss of profits or confidential or other information, for business interruption, for personal injury, for loss of privacy, for failure to meet any duty including of good faith or of reasonable care, for negligence, and for any other pecuniary or other loss whatsoever) arising out of or in any way related to the use of or inability to use this Software.

15. Licensor's cumulative liability to Licensee or any other party for any loss of damages resulting from any claims, demands, or actions arising out of or relating to this agreement shall not exceed the larger of the license fee paid to Licensor for the use of this Software.

16. Licensee acknowledges that this EULA constitutes the entire agreement between Licensee and Licensor relating to this Software, and supersedes all prior or contemporaneous oral or written communications, proposals, and representations regarding this Software. This EULA is not, however, to limit any rights that Licensor may have under trade secret, copyright, trademark, patent, or other laws that may be available to it.

17. If any provision of this EULA is invalid or unenforceable under applicable law, it is, to that extent, deemed omitted and the remaining provisions will continue in full force and effect.
